

## TERMS OF USE FOR THE EUROSTATUS SERVICE

If you do not agree with this provision or with its individual clauses, you have the right to refuse to use the Eurostatus Service (Service)

If you are a user of the Service, this automatically means that you accept all clauses of this Agreement.

### 1. TERMS AND DEFINITIONS

Service - a set of legal and actual actions, as well as software and hardware, united by the space of the Eurostatus.com domain name and associated unique addresses and software systems that ensure interaction between Users and Eurostatus in the provision of temporary staff services.

Account - a unique name (login) and password for access to the User's personal pages within the Service (personal account)

Customer - a User who orders temporary staff services within the Service.

Contractor, Freelancer - a User who provides services for performing various types of work, who entered into a legal relationship with the Service on the basis of an offer contract.

### 2. BASIC PROVISIONS

2.1. By accepting this Agreement, the User agrees, accepts, and undertakes to unconditionally follow all of its terms, and the User also has the right to refuse to use the Service.

2.2. The Service provides Users with a service to access the functionality of the Service

### 3. RIGHTS AND OBLIGATIONS OF THE PARTIES

#### 3.1. User's rights and obligations

3.1.1. The user is responsible for the accuracy and accuracy of filling out his profile, as well as all information posted by him on the Site.

3.1.2. Users acknowledge and agree that Eurostatus representatives have access to all contents of the Service, including private messages on the Service.

3.1.3. Users should not attempt to gain unauthorized access to any part or function of the Service, or any other systems or networks connected to the Service, or to any server of the Service, by any illegal means.

3.1.4. All users of the Service can register no more than one account. Registration of multiple accounts of the same type is prohibited, as well as the transfer of login parameters to the service to other users.

3.1.5. It is forbidden to transfer accounts to third parties. One account belongs to one person.

3.1.6. Purchase and sale of accounts is prohibited.

3.1.7. All users of the Service are obliged to fulfill their obligations in good faith both to the administration of the Service and to their counterparties (in the case of concluding deals with the latter).

3.1.8. It is forbidden to use tools for mass mailing of private messages or automatically adding rates to projects.

#### 3.2. Eurostatus rights and obligations:

3.2.1. Eurostatus defines the rules for the provision of the Service and reserves the right to require Users to comply with them.

3.2.2. Eurostatus has the right to send information messages to Users exclusively within the framework of using the Service.

3.2.3. Eurostatus is not responsible for the accuracy of the information provided by the Users.

3.2.4. By providing Eurostatus with their email address and telephone number, Users consent to the use of this data to send Eurostatus service, information and marketing notifications.

3.2.5. The user provides their unconditional consent to the processing of personal data by Eurostatus in order to exercise the rights and fulfill the obligations arising from the provisions of this Agreement. Processing includes, but is not limited to, the collection, registration, storage, adaptation, updating, use and destruction of personal data. The parties are notified that since the conclusion of this Agreement.

#### 4. ACCESS TO THE SERVICE.

##### FOR CUSTOMERS:

Step 1. To receive a service for attracting temporary personnel (freelancers) to facilities, you must provide Eurostatus with constituent documents and a request for the type and scope of services indicating the region of service provision (specification to the level of the settlement).

Step 2. The customer forms an application for the performance of work with an indication of the competency profile of temporary personnel (freelancers).

Step 3. The customer monitors the received messages about the beginning and completion of work

##### FOR FREELANCERS:

Interaction with the service from the moment of registration on the platform to receiving remuneration for the work performed is carried out through the Personal Account.

When visiting offices / recruiting platforms, the Freelancer is provided with a login for identification when entering the Personal Account on the site. The login is the numbers of the code without zeros, the freelancer comes up with the password himself, for identification he receives an SMS message with the code.

At the initial entrance to the personal account, the freelancer is asked to confirm the offer agreement with the Eurostatus company. After confirming the offer, all services of this tool are available in your personal account.
